Huron County Council met in the Council Chambers on Wednesday October 7<sup>th</sup>, 2009. Warden Oke called the meeting to order at 9:02 a.m.

Chief Administrative Officer Larry C. Adams called the roll and all members of Council were present except for Councillors J. Bezaire and D. Shewfelt. Councillor B. Dowson arrived at 9:05 a.m.

Warden K. Oke welcomed all present to the Tenth Session. He reviewed his Warden's report for the month of September. Warden Oke reported he attended the 100<sup>th</sup> Anniversary of the Ontario Provincial Police (OPP) in London.
