# **INAUGURAL SESSION HURON COUNTY COUNCIL**

Goderich, Ontario  
December 2<sup>nd</sup>, 2009.

The duly elected County Councillors of the County of Huron for the years 2007 - 2010 met in the Council Chambers at 1:02 p.m. with the 2009 Warden, Ken Oke presiding.

Warden Oke welcomed the members of Huron County Council and guests to the Inaugural Session.

C.A.O. Adams called the roll and all members of Council were present except for Councillor B. MacLellan.

Moved by: Councillor M. Scott and Seconded by: Councillor J. Fergusson:

The C.A.O. proceed with the election of Warden for 2010; as set out in the County of Huron Procedural By-law No. 26-2009.

C.A.O. Adams called for nominations for Warden for 2010.

NOMINATIONS FOR WARDEN:

Councillor J. Grace, Town of Goderich, nominated Councillor B. Dykstra, Municipality of Central Huron, as a candidate for Warden for 2010.

Councillor D. Shewfelt, Town of Goderich, nominated Councillor D. Kelly, Municipality of Morris-Turnberry, as a candidate for Warden for 2010.

There being no further nominations, C.A.O. Adams declared nominations closed.

The candidates for the 2010 Warden's position: namely; Councillor B. Dykstra and Councillor D. Kelly, addressed Council briefly.

C.A.O. Adams then conducted the election by secret ballot in accordance with the County of Huron Procedural By-law No. 26-2009. One ballot ensued.

Ben Lobb, M.P. for Huron-Bruce was unavailable to attend the Inaugural Session. In M.P. Lobb's absence, Bill Strong the Constituency Manager for M.P. Lobb's Goderich office was in attendance and brought greetings from the Government of Canada and congratulations to Warden Dykstra.

Chuck Reid, Director of Education, Avon Maitland District School Board, addressed Council and congratulated Warden Dykstra. Also in attendance from the Avon Maitland District School Board, was Chair of the Board of Trustees Jenny Versteeg.

Carol Mitchell, M.P.P. Huron-Bruce and the Huron-Perth Catholic District School Board were unable to attend and sent their regrets.
