Huron County Council met in the Council Chambers on Wednesday June 2nd, 2010. Warden Bert Dykstra called the meeting to order at 9:04 a.m.

Chief Administrative Officer Larry C. Adams called the roll and all members of Council were present except for Councillors J. Bezaire and B. Dowson.

Warden Dykstra welcomed all present to the Seventh Session. Warden Dykstra reviewed the Warden's report for the month of May.

Petitions and Deputations:

Stacey Reisma, Huron County Queen of the Furrow attended the Seventh Session of Council to promote the 2010 Huron County Plowing Match that will be held on August 26th and 27th, 2010.

Karin Mabon, Adjustment Advisory Co-ordinator, Volvo Construction Equipment Canadian Operations was present to update Council on the employment status of the employees from Volvo.

Councillor's Issues:

Councillor Seili advised that some of the senior tenants at 400 Alexander Street, Brussels are looking to relocate to other apartments in Brussels. Director of Social Services Dave Overboe advised there is a report coming to the COTW Day 2 meeting on June 16th.

Councillor Seili advised a group of residents from McKillop Ward who are against wind turbines are working toward setting up a working group to look into the issues of wind turbines. The Municipality of Huron East has put forth a motion for support against wind turbines and *the Green Energy Act*. Councillor Seili would like the County Planning and Development Department to support this group.

Councillor Shewfelt expressed a concern with Councillor Seili's suggestion.

There was a great deal of discussion regarding the Ontario Power Authority and the delays involved in the approval process of applications for contracts under the microFIT program. It was reported that there have been several thousand applications forwarded and only 700 applications have been approved by the Ontario Power Authority since November 2009.
