The County of Huron BOARD OF HEALTH met in the Court House Council Chambers, Goderich at 9:05 a.m. with all members present.

Councillor's Issues

Warden K. Oke reported that he has received complaints that it is difficult for those sitting behind the rail to hear what is being said during the Board of Health and Library Board meetings. Councillors may sit on the sides of the Council Chambers during these meetings.

Councillor D. Johnston requested an "In Camera" with the CAO and Councillors for a personnel matter. B. MacLellan, the Board of Health Chair indicated that this "In Camera" issue will be dealt with later today.

Councillor B. Dykstra requested an up-date on the status of a public representative for the Board of Health. L.C. Adams, CAO, reported that the search is temporarily on hold due to other important issues. Warden K. Oke asked for and received clarification that the appointment would be from the general public.

2. Outbreaks

Christina Taylor, Public Health Manager provided a verbal update on current disease outbreaks at health care institutions for the information of the Board and Council.

Two respiratory outbreaks and one enteric outbreak have been reported to the Health Unit since February 11, 2009. All three outbreaks were investigated and quickly brought under control with the assistance of the facilities. No causative agents were identified for any of the outbreaks.

The Huron County Health Unit has received report of 26 cases of influenza since January 1, 2009. The numbers are slightly above last years numbers. However March 2008 was a record breaking year with over 50 cases being reported.

3. New Infection Control Practitioner Position

Christina Taylor, Public Health Manager presented the attached report (Appendix A) for the information of the Board and Council. She confirmed that the \$80,000 provided by the Ministry for the recruitment of one Infection Prevention and Control Nurse would be continual funding.

We have had the opportunity to revisit our initial decision and are now recommending that a Public Health Nurse be hired into the position of Infection Control Practitioner. We can not be short sighted and plan only for today. Public Health is now changing with the new program standards, there is an increasing movement towards surveillance, awareness and total population health therefore a PHN would be much better qualified for this role and bring the additional skills that are required to move forward.

Registered nurse job descriptions and duties are limited to clinical services and the implementation and evaluation of program services. Where as a Public Health Nurse brings those skills as well as the competency to plan and lead. It will give us the flexibility to manage the ever changing environment.

Because of the increased qualifications, a further investment of \$5767.00 is needed. We have reviewed the current budget and with slight modifications to another position can make it work. I strongly encourage you to accept the position as a PHN and assist us in meeting the ministry requirements and protecting the health of the residents of Huron County.
