## BOARD OF HEALTH

The Board of Health met in the Auditorium at the Health Unit in Clinton on the 5<sup>th</sup> of November, 2009. Chair B. Health and stated it was a pleasure working with Dr. Cameron. He also thanked the members of the Board of Health for their participation and interest for the past year.

The immunization area is small and using the tent has worked out very well.
