The Ministry has now given the Health Unit guidelines and a total operating budget to form the basis of their submission and to construct a low income dental program that meets the needs of the local community. The Health Unit is continuing to work with community partners to develop a program based on Ministry guidelines and funding and will follow up with the Board at the next meeting.

He answered a question concerning the 2010 Drinking Water Advisories regarding the Grey (School) that is commonly known as the Walton Little School that is a day care. There was some confusion as there is a Grey Central Public School in Ethel.

Dr. Nancy Cameron, Medical Officer of Health/CEO will present a Report entitled Medical Officer of Health Update, for the information of the Board.

Dr. Cameron gave an update on HAS and Choices for Change. She has been advised that Choices for Change are still meeting with the LHIN. There should be some confirmation shortly from LHIN regarding the changeover.

Dr. Cameron advised the summer students have been hired and some have started to work for the Health Unit. The summer students are a great assistance to the Public Health Inspectors as they assist with inspections and come with lots of enthusiasm and knowledge.
