# **Huron County Council**



**Minutes - June 1, 2006**

**Seventh Session**

*GODERICH, ONTARIO*

Huron County Council met in the Council Chambers on the above date at 9:00 a.m.

The Chief Administrative Officer called the roll and all members were present except Councillor J. Bezaire and Councillor D. Shewfelt.

Minutes of the previous Session being May 2, 2006 were adopted as circulated on motion of Councillor B. Van Diepenbeek and Councillor B. MacLellan.

**COUNCILLOR'S ISSUES**

Larry Adams, CAO, informed Council that he received a memo from the County of Lambton regarding a bus to the AMO Conference in August. Would anyone from Huron County be interested in joining the County of Lambton?

Warden R. Morley spoke regarding Vote for Wingham who is competing for the Title of Kraft Hockeyville 2006. The Warden also reminded Council of the Tour of Suntastic Green Houses and BBQ on June 17, 2006.

Councillor E. Connelly informed Council that the Goderich Marine Heritage Committee is hoping to sink a ship off Black's Point, south of Goderich, in August. This event will be good for the County and will enhance economic development.

1. In Section 3(1)(d), perhaps a specific colour or colours should be specified in accordance with the general practice of Registered Professional Foresters. In this regard, perhaps you could contact Mr. Smith and ask for his comments.
2. At the bottom of the first page of Schedule B, being the Notice of Intent, we suggest the last sentence on the first page of the Notice be amended to read: "If the woodland or woodlot is not harvested within 180 business days of receipt of this Notice of Intent, this Notice is null and void."
3. Paragraph 9(10) be added - "In the computation of time under this By-law, where there is a reference to a number of days between two events that is less than 30 days, they shall be counted by excluding Saturdays, Sundays and holidays and the day on which the first event happens and including the day upon which the second event happens."

Discussion took place. That Amendment No. 2 and Amendment No. 3 be incorporated into the Draft By-law. These Amendments are to be forwarded to the lower tier municipalities.
