Huron County Council



Minutes - March 7, 2007

Fourth Session

GODERICH, ONTARIO

Huron County Council met in the Council Chambers on the above date at 9:00 a.m.

The Chief Administrative Officer called the roll and all members were present except Councillor J. Seili.

Warden D. Shewfelt welcomed the members to the Session and the Page, Dustin Court. Councillor B. Dykstra introduced Dustin, a Grade 8 student at the St. Joseph's Catholic School in Clinton.

Minutes of the previous Sessions being February 7, 2007 and February 20, 2007 were adopted as circulated on motion of Councillor B. MacLellan and Councillor J. Bezaire.

Councillor T. Collyer declared a pecuniary interest in connection with Clause #4 of the Health, Ambulance and Social Services Committee Report dated February 13, 2007, being Report #12.

PETITIONS AND DEPUTATIONS

Bill Thibert, President and CEO, Alexandra Marine and General Hospital (AMGH), was in attendance and spoke to Council who had questions at the Committee of the Whole meeting of February 20, 2007 regarding the breakdown of the dollars for the CT Scanner.

Also presenting were: Dr. Don Neal; Willi Laurie, Co-Chair of the CT Scanner for Huron County Campaign Committee; and Diane Schultz, Campaign Co-ordinator.

Discussion took place and the following questions and answers were dealt with:

- Ü With operating costs of \$450,000, how can this be handled? Is there a plan in place? Yes - There are capitalizing maintenance contract fees of \$130,000 per year plus other efficiencies in the hospital. AMGH has an annual Budget of approximately \$20 million and the CT Scanner is important enough to find the dollars.
- Ü Has Ministry approval been received? No, not yet but the necessary paperwork has been submitted and feel confident to receive approval this Spring.
- Ü The present Radiologist will soon be retiring and has someone been hired to replace him? A Radiologist from New Brunswick had agreed to come to Goderich but recently advised the Hospital of his decision to decline the position. Follow-up is being done on a number of other leads and further recruitment efforts are being put in place. After Ministry approval, it will take approximately nine months to get the CT Scanner in operation. Once the Picture Archival Communications System (PACS) is installed, you are able to send the CT Digital Scans to a Radiologist in London or elsewhere for interpretation. It will be very difficult to attract a Radiologist without a CT Scanner to work with.
- Ü Are there going to be user fees to offset the cost of the CT Scanner? It is illegal to do this as guidelines and rules have to be adhered to as not to contravene the Public Hospital's Act.
- Ü With the CT Scanners coming to the smaller communities and becoming a standard diagnostic tool, the Ministry may be considering to provide some operating funding to hospitals.

- Ü What is the difference between a CT Scanner and a MRI? Both are diagnostic imaging tools and have different roles. A CT Scanner is an everyday tool for diagnosing and treatment where the MRI is used for specific areas and is a secondary tool. Sometimes one or the other is more useful. MRI are located in larger communities and are operated in combination with a CT Scanner.
- Ü The campaigning in Owen Sound was heavily supported by the neighbouring counties and regional use. Hope that Huron County does the same.
- Ü Support staff is needed and where will they come from? Most hospitals have a shortage of nurses. The AMGH is not currently experiencing a nursing shortage and have a number of technicians working to upgrade their skills in order to operate a CT Scanner.
- Ü When the Ambulance Service is used, how are the patients diagnosed? If there are signs of a stroke, a CT Scan is needed to determine whether the cause is due to bleeding or a blood clot in the brain. Need to be transported quickly to a CT Scanner to determine if "clot busting" medication can be given as there is a tight window of approximately two hours to avoid/limit impending brain damage. The Ambulance crew if diagnosed will go directly to Stratford or London. Goderich could be another stroke centre.
- Ü Will other counties be lobbied for funding? Not at this time. They have their own scanners so will be campaigning within Huron County and will develop a plan to ask the Service Clubs for funding.
- Ü With the first two hours being critical, will the CT Scanner be available twenty-fours a day? Yes - staff will either be on site or on call twenty-four hours per day.
- Ü The need is not a question and either is the cost of the CT Scanner. The Councillor's concerns were with the financial breakdown of the total cost of the project and were appreciative of the clarifications presented today.

The CAO commented that there are two Public Meetings coming up for Budget deliberations and so it is premature to make a decision right now. The draft budget is being distributed today.

Councillor B. MacLellan attended a presentation regarding Gasification at the ROMA/OGRA Conference in February from Plasco Services. This company covers the entire cost of building the facility which would effectively eliminate large amounts of waste without polluting the air. There is no perpetual care necessary for such a site, as opposed to landfills that are the municipalities. This would eliminate our landfill issues. Scott Tousaw, Planning Director, informed Council that while the technology is worth investigating, it is only in its experimentation stages and an environmental assessment will have to be completed. It would be of interest of Council to have that firm present to Huron County Council.
