



Huron County Council Minutes - March 4, 2009

Fourth Session

GODERICH, ONTARIO



Huron County Council met in the Council Chambers on the above date at 9:00 a.m.

The Chief Administrative Officer called the roll and all members were present except Councillor B. Dowson.

Warden K. Oke welcomed the members to the Session and the Page, Matthew Adams. Councillor T. Collyer introduced Matthew, a Grade 7 student at St. Mary's School.

Minutes of the previous Sessions being February 4, 2009, February 11, 2009 and February 17, 2009 were adopted as circulated on motion of Councillor J. Dietrich and Councillor B. MacLellan.

PETITIONS AND DEPUTATIONS

Huron Perth Farm to Table - Jane Muegge, Regional Information Co-ordinator, OMAFRA, and Janice Dunbar, Community Developer from the Health Unit, made a presentation to Council.

The Huron Perth Farm to Table group represents a variety of agencies, organizations and primary producers. One of the aspects that we support, encourage and promote is the Good Food Box.

The Huron Good Food Box reflects the vision of the Huron Perth Farm to Table Committee." A sustainable, financially viable community enterprise that enhances food security and nutrition for Huron County residents while creating new market opportunities for local suppliers of food." The Good Food Box provides Huron County residents with local vegetables and fruits monthly. It is a community-based project that relies on volunteers. Buying in large quantities from our local producers allows us to get better pricing. The result is that the consumer gets better value, our health improves, the local economy is enhanced and one aspect of food shopping becomes incredibly convenient.

A presentation was made to County Council so that they can in turn promote within their municipalities how it operates and its personal health and local economic benefits. The Good Food Box is available to all residents of Huron.

Some areas covered were:

- how the program operates, who can be involved
- product that has been purchased to date
- economic impact
- health impact
- how residents can take part
- how municipalities can help

Good Food Boxes were on display and a box for each County Councillor was distributed. This is a fabulous way to highlight and kick-off Nutrition Month (March).

Clause 2.2 - Clarification of Archives Research Fees

The original motion is as follows:

"It is recommended that:

1. That the day pass fee be waived under the following conditions:
 - a) the applicant be a non-profit group located in the County of Huron;
 - b) applications be in writing from the organization, naming the researchers who will be accessing the Archives and Reading Room and the nature of the project;
 - c) two copies of the published books be provided to the County (1 for the Museum, 1 for the county library).
2. That the day pass fee be waived for students under the following conditions:
 - a) they must show proof of enrollment in an educational institution;
 - b) the research they are doing is for a current project in their curriculum.
3. That the day pass fee be waived for researchers under the following conditions:
 - a) they are residents of Huron County;
 - b) they are working on a current project with or for the Huron County Museum or another County department on a voluntary basis.

That the recommendations be approved. CARRIED"

Councillor J. Seili commented on this report. Why do a budget if we turn around and do something like this? Warden Oke commented that there is money involved but the budget stays the same.
