## **FIFTH SESSION HURON COUNTY COUNCIL**

Goderich, Ontario  
April 7<sup>th</sup>, 2010.

Huron County Council met in the Council Chambers on Wednesday April 7<sup>th</sup>, 2010. Warden Bert Dykstra called the meeting to order at 9:05 a.m. Warden Dykstra welcomed Ben Lobb, MP Huron-Bruce, Jennifer Hubbard representing the Honourable Carol Mitchell, MPP Huron-Bruce, and the Past Wardens of Huron County; to the Fifth Session of Huron County Council.

Chief Administrative Officer Larry C. Adams called the roll and all members of Council were present.

A public meeting to consider one-third of the remuneration paid to members of Council and its Local Boards to be deemed as expenses was held prior to the Fifth Session.

Warden Dykstra reviewed the Warden's report for the month of March 2010.

Warden Dykstra called on Councillor M. Demaray to introduce the Page for the Fifth Session. **Petitions and Deputations:**

Warden Dykstra called on Ben Lobb, MP, Huron-Bruce to bring greetings on behalf of the Government of Canada. MP Lobb highlighted some of the events that have taken place over the past month. MP Lobb was honoured to make an announcement on April 6<sup>th</sup> in the Municipality of South Huron. Goderich Aircraft received funding in the amount of 4.4 million dollars. Goderich Aircraft is refurbishing aircrafts for clients in the Middle East. This is welcome news for Huron County's economy.

Jennifer Hubbard brought greetings from the Province of Ontario on behalf of the Honourable Carol Mitchell, MPP, Huron-Bruce. Minister Mitchell was unable to attend due to other engagements and sent her apologies.

Past Warden/Councillor Bill Dowson brought greetings form the Past Warden's Association. Murray Elston, Vice President of Corporate Affairs, Bruce Power and Ross Lamont, Manager, Community and Government Relations, Bruce Power; were present to update Council on the activities at Bruce Power. Members of Council were given an opportunity to ask questions.

Nuisance Coyotes:

Beverly Stevenson, Senior Fish & Wildlife Specialist, Ministry of Natural Resources delivered a power point presentation. Bob Trick, Animal Control Officer for various lower tier municipalities in Huron County; advised he would personally like to see the compensation for coyote pelts increased from \$50 to \$100. The compensation is only paid if there has been a confirmed livestock kill on a property and the necessary paperwork is completed by the Animal Control Officer and the Ministry of Natural Resources approves the harvesting of nuisance coyotes.

Chris LaForest, Director of Planning and Development, Bruce County advised that nuisance coyotes are a problem for sheep farmers in particular; in Bruce County. Bruce County recently increased the compensation from \$50 to \$100 per coyote killed; with the mandatory paperwork and necessary approvals in order.

Mr. LaForest would like to see a regional approach adopted by Huron, Bruce and Grey Counties for the nuisance coyotes. Much of the problem for farmers with dead livestock is the proper process to dispose of the dead stock. There needs to be more education and awareness raised for rural property owners.

**Councillor's Issues:**

Councillor K. Oke followed up on the information presented earlier by MP Ben Lobb; the announcement by the Honourable Dr. Gary Goodyear, Minister of FedDev Ontario that Goderich Aircraft received a 4.4 million dollar interest free loan. This will enable Goderich Aircraft to expand and within a few years, expectations are that they will be employing up to 450 employees. The employees will come from the surrounding area such as; Perth and Middlesex Counties as well as Huron County. This is good news for our entire area.

Councillor J. Bezaire discussed the issue of fire protection throughout the County. Councillor Bezaire would like the County to take the lead role in providing this service.

There were some comments from other members that were not favourable to the County taking over fire protection from the lower tiers. It had been discussed in a Strategic Planning meeting and was turned down at that time.

Warden Dykstra requested anyone wishing to discuss this further to indicate with a show of hands. The majority of Council indicated they were opposed to continuing this discussion.

Councillor B. Siemon congratulated the Library staff at the Seaforth Library for their recent recognition as the Best in Class designation under the Municipal Energy Performance Benchmarking Project. Local Authority Services Ltd., (LAS) a wholly owned subsidiary company of AMO and more than 140 municipalities worked with a consortium led by Marbek Consultants on the

Municipal Energy Performance Benchmarking Project. Seaforth Library staff is to be commended for this achievement which was primarily due to their diligence.

Councillor Vincent shared some good news about the F.E. Madill Secondary School Girls Hockey team. They recently won the OFSSAA Hockey Tournament. Many of the girls on the team are residents of northern Huron County.

Councillor M. Demaray reported the flag he indicated was in need of replacing at the Wingham Public Works Yard had been replaced. He passed his thanks along for this. Councillor Demaray also reminded everyone of the Belmore Maple Syrup Festival to be held on Thursday April 8<sup>th</sup> and Saturday April 10<sup>th</sup>. He also invited everyone to attend the Howick Township Firemen's Breakfast at the Fire Hall in Gorrie on April 25<sup>th</sup> from 8:00 a.m. until noon.

Councillor MacLellan questioned the County's Hiring Policy. A business from Bluewater recently contacted Councillor MacLellan expressing his frustration with hiring and training his employees over the past two years. Once they were trained at his expense; they left to go work for the Huron County Health Unit.

CAO Adams confirmed that the County advertises for any job vacancies they may have. The County endeavours to hire the best possible candidates for the positions available and there is absolutely no corporate/industry "poaching". It is unfortunate for the individual who was talking to Councillor MacLellan; however the County must be completely accountable and transparent with their hiring policies.

Councillor Oke commented that the Municipality of South Huron was encountering the same problem with employees leaving to go and work for the County of Huron. He advised that subsided when South Huron started paying better wages.

**Correspondence:**

CAO Adams brought to everyone's attention the Howick Township Fire Department Firemen's Breakfast that Councillor Demaray had discussed earlier. He also commented on the Huron County Health Unit 2009 Annual Report. The items that are highlighted in blue on the Report are links to

various web sites that will give a wealth of information. Councillor Bezaire complimented the Health Unit and Dr. Cameron on a very informative Annual Report.

Board of Health

Members of Council were given an opportunity to review the minutes of the regular Board of Health meeting held on March 4<sup>th</sup>, 2010. Councillor D. Johnston, Chair of the Board of Health was available to speak to the minutes and the reports.

Councillor Johnston requested the Report on Holiday Hours be moved to the COTW Day 1 Agenda on Wednesday April 14<sup>th</sup>. This request from Councillor Johnston was so that Darcy Michaud, Director of Human Resources, could be in attendance for that portion of the meeting.

Councillor Van Diepenbeek commented on the proposed County-wide Mandatory Septic System Mandatory Inspection Program presentation recently made at their Council. He advised that Ashfield-Colborne-Wawanosh (ACW) Council has recently considered and supported the program. ACW are investigating methods to financially assist residents in ACW that are in need of septic repair or replacement and that would qualify for financial assistance. Councillor Van Diepenbeek suggested it is time to move ahead with this program and that the County had considered a loan style program for qualified septic system repairs, for the past several years.
