## **SIXTH SESSION HURON COUNTY COUNCIL**

May 5<sup>th</sup>, 2010.

Huron County Council met in the Council Chambers on Wednesday May 5<sup>th</sup>, 2010. Warden Bert Dykstra called the meeting to order at 9:02 a.m.

Chief Administrative Officer Larry C. Adams called the roll and all members of Council were present. Councillor J. Bezaire arrived at 9:21 a.m. Councillor D. Shewfelt left the meeting at 11:20 a.m.

Warden Dykstra reviewed the Warden's report for the month of April 2010.

Warden Dykstra called on Councillor J. Seili to introduce the Page for the Sixth Session. Shelley Dorey, Executive Director of Victim Services Huron County delivered a presentation about the services provided to Huron County residents by Victim Services. This is a non-profit volunteer-based organization with 65 volunteers who offer short term emotional support to victims of crime or trauma. This organization is funded through the Ministry of the Attorney General.

Jan Vogel, a Volunteer Crisis Responder and the Co-Chair for the Huron County Victim Services Fundraising Committee was also present. Ms Vogel invited members of Council and staff to attend the Victim Services fundraiser entitled "Dancing with the Stars". In 2009 this fundraiser raised approximately \$14,000 with the proceeds to go toward discretionary items needed for the victims of crime or trauma.

Dr. Caldwell is a leading professor, researcher and practitioner. He is noted for his commitment to excellence in his profession, dedication to students and rural community development and public participation, environmental stewardship. Dr. Caldwell is a planning consultant for the County of Huron Planning and Development Department.

Beth Ross, Director of Cultural Services announced the County of Huron has been notified that an application for support under Parks Canada's National

Historic Sites of Canada Cost-Sharing Program has been approved for up to \$313,188 for a conservation project at the Huron Historic Gaol. Matching funds will be provided from the County's capital reserves.

The conservation project consists of the masonry restoration of the stone at the north Gaol entry portico, exterior walls, and Governor's House, the restoration of the centre block lantern (or cupola), and replacement of the roof on the Governor's house. The furnace boiler and fire alarm system will also be replaced. Details from Parks Canada are forthcoming and the work must be completed by March 31<sup>st</sup>, 2011.

**Correspondence:**

Dr. Cameron does not have to attend all County Council meetings; only the meetings she is requested to attend.

There was a brief discussion regarding the mandatory septic system inspection program. The municipalities are all having a presentation from Bob Worsell, Public Health Inspector and Susanna Reid, Planner at their Council meetings.
