June 1st, 2011.

Huron County Council met in the Council Chambers on Wednesday June 1st, 2011. Warden Neil Vincent called the meeting to order at 9:02 a.m.

In CAO Larry C. Adams' absence, Deputy CAO/Treasurer David Carey called the roll and all members of Council were present except for Councillor J. Grace.

Warden Vincent welcomed all present to the Seventh Session. Warden Vincent reviewed the Warden's report for the month of May.
