


Accessibility Advisory Committee

Minutes - June 20, 2011



HURON COUNTY ACCESSIBILITY ADVISORY COMMITTEE (HCAAC)

Goderich, Ontario June 20th, 2011.

The Huron County Accessibility Advisory Committee met in the Court House Council Chambers on the 20th of June, 2011. The meeting was called to order at 9:38 a.m. by Chair D. Frayne. Chair Frayne welcomed the members to the meeting. All members of the Committee were present except Member Kevin Dickins.

Staff present were; CAO Larry C. Adams, ODA Working Group Representative Lynda Rotteau, Planner Claire Dodds, Accessibility Coordinator Sandra Thompson and County Clerk Barb Wilson. Regrets were received from Robyn de Weerd and Kirk Livingston.

Accessibility Coordinator Sandra Thompson reported she had been in contact with two potential new members for HCAAC. Tracey Carter has expressed an interest in becoming a member of the Huron County Accessibility Advisory Committee in the capacity of a Professional. Tracey works with people with disabilities. Amanda Wattam is interested in becoming a member of HCAAC. Amanda has a bone disease that presents challenges to her daily living routine.

9. Integrated Accessibility Standard Now Law – Next Steps:

Accessibility Coordinator Sandra Thompson reported that the Integrated Accessibility Standard is now law. The timeline for some of the regulations is July 1st, 2011; however this will not impact Huron County as Huron County does not have public transit.

10. Presentation from Brad Knight from Huron East – Renovations to the Brussels Pool:

Brad Knight, Treasurer of the Municipality of Huron East delivered a power point presentation on the accessibility improvements that are being done to the Brussels Morris Grey (BMG) Pool. The Municipality of Huron East has made application to the Ontario Trillium Foundation for partial funding. The Brussels Lions Club is a partner in the accessibility renovations at the BMG Pool. The announcement of the funding application should be around July 1st, 2011.

Possible Future Agenda Items:

1) The comments and recommendations from the Site Plan Review Committee should be copied to the Building Officials in the member municipalities. There was a break down in communication with the Arena in Seaforth. The Building Official did not receive the comments and recommendations from the Site Plan Review Committee so the recommendations from the Site Plan Review Committee were not completed.

Sandra Thompson will ensure that the Building Officials for the lower tiers are copied with the comments and recommendations from the Site Plan Review Committee. HCAAC will also receive a copy of those comments and recommendations at the meeting held immediately following the submission of the comments and recommendations.

A letter will be sent with the comments and recommendations requesting that the Building Officials respond; if possible, to HCAAC advising of the recommendations that were completed and the reason why the recommendations were not completed.

Paul Josling the Chief Building Official from the Municipality of Huron East was in attendance and confirmed that the he did not receive the comments and recommendations from the Site Plan Review Committee regarding the Seaforth Arena. CBO Josling is in agreement with the comments and recommendations being sent to the member municipality Chief Building Officials as well as the municipality.

CAO Adams suggested that at our next meeting all the member municipality's Chief Building Officials be invited to come and share a cup of coffee and a muffin or donut with the Committee members.

Accessibility Coordinator Sandra Thompson will send out letters to all the Chief Building Officials in Huron County in lots of time for them to schedule the date of the next meeting into their calendars.

- 2) A suggestion of an Accessibility Guide for facilities in Huron County be discussed. The suggestion included; for example; a specific recreation facility, identifying if there good accessible parking, washrooms, heated viewing area etc.
- 3) A question from a member asked if the Site Plans for the Knights of Columbus Community Hall in Goderich have been received yet. Lynda Rotteau will follow up with this question.
- 4) A request from a member for the audible sound system at the five points intersection in Goderich be repaired and maintained. Lynda Rotteau will follow up with this request and the Town of Goderich.
