## PUBLIC MEETING HURON COUNTY COUNCIL

Goderich, Ontario October 2, 2012

Warden G. Robertson acted as Chair for this Public Meeting and called the Public Meeting to order at 9:00 a.m.

All members of Council were present except Councillors Dietrich and Klopp.

Chair Robertson advised that the purpose of the Public Meeting was to provide information and receive public input on a proposed Memorandum of Understanding between the Town of Goderich and the Municipality of Central Huron pertaining to the boundary adjustment.

## **Declarations of Pecuniary Interest:**

There were no declarations of pecuniary interest stated.

Chair Robertson requested anyone present from the public in favour of the boundary adjustment between the Town of Goderich and the Municipality of Central Huron to step to the lectern and state their name and provide comments to Council for the record.

Councillor Shewfelt stated that the Town of Goderich was in favour of the boundary adjustment based on a strong partnership between Central Huron and Goderich, upgraded services, new development, jobs and growth.

Councillor Ginn stated that he echoed Councillor Shewfelt's comments. There will be potential for an increase in economic development, construction jobs and population that will support local businesses.

Councillor Gowing stated his support for this boundary adjustment as it was positive for the whole County, similar to the recent boundary adjustment and service agreement between North Huron and Morris-Turnberry which is now attracting development, including a large subdivision.

Chair Robertson requested anyone present from the public opposed to the boundary adjustment between the Town of Goderich and the Municipality of Central Huron to step to the lectern and state their name and provide comments to Council for the record. There were none.

No other person spoke in favour of the proposal.

Members of Huron County Council were given an opportunity to ask questions and make comments. There were no questions or comments.
