The purpose of this application is to sever a surplus farm residence. The proposed severed parcel is 2.2 hectares (5.5 acres) in size and contains a residence and two sheds. The proposed retained parcel is 37.4 hectares (92.5 acres) if corresponding consent file C32-2023 is finalized and is vacant farmland. The Department is recommending approval of the application with conditions, including a condition requiring the severed parcel to be reduced in size to 0.6 hectares (1.5 acres). Council of the Township of Ashfield- Colborne-Wawanosh recommends approval of the application with conditions, except condition #7 (reduction of the severed parcel).

9.2. Consent File C62-2020, Joanne Oliver (Applicant), Lot 165 of Plan 147, Bayfield Ward, Municipality of Bluewater, County of Huron (presented by Denise Van Amersfoort)

The purpose of this application is a lot enlargement. The proposed land to be severed is approximately 192 square metres and is currently vacant. The severed lands would be merged with the property to the south which contains a commercial building. The proposed retained lands contain a single detached dwelling.

The subject property is designated Residential in the Bluewater Official Plan and zoned Residential Low Density (R1). The lands with which the severed is to merge are designated Core Commercial and zoned Core Commercial (C4). The purpose of the lot enlargement is to facilitate the addition of an access lane to the rear of the commercial property. The application is disputed by neighbours and community members who do not wish to see the commercial area encroach further north along Bayfield Main Street North. The Municipality of Bluewater is recommending approval with conditions.
